



Memorandum of Understanding (MOU)

Between GRACE Charity / CDC [P.O. Box 611, Mzuzu] and Mr. Esau Zayoyoka Banda [student at Mzuzu University (MZUNI) Private Bag 201, Luwingu, Mzuzu], hereafter cited as the **Trainee**.

Purpose: The agreement is a support of the **Trainees** education to pursue the award of **DIPLOMA in EDUCATION** at **MZUNI**.

Agreement: The **Trainee** will get a gross assistance of **Malawi Kwacha 495'000** (495 thousand Kwacha) **over 3 years**. The aid will split in 6 instalments (**see addendum on costs attached**).

GRACE will pay instalments to the **MZUNI** bank account straightaway. The **self-contribution of Malawi Kwacha 165'000** (= 25% of the total fees) must be settled by the **Trainee** himself.

The **Trainee** agrees to run **1 activity** at Chipunga community per calendar year. The activity must be announced to and agreed by CDC (e.g. role model to young learners at primary schools of the area). The **Trainee** further agrees to give **two short annual reports** on his education progress to GRACE charity (at mid and end year). It is anticipated the **Trainee** communicates with GRACE by either e-mail, facebook, or whatsapp.


Clause: **Payment can be stopped** by CDC at any time if the **Trainee doesn't accomplish** his given obligations or **Chipunga Community doesn't stick** to their acknowledged self-contribution tasks concerning other GRACE projects. Decision of ruling an interruption or stop will be made by CDC.
